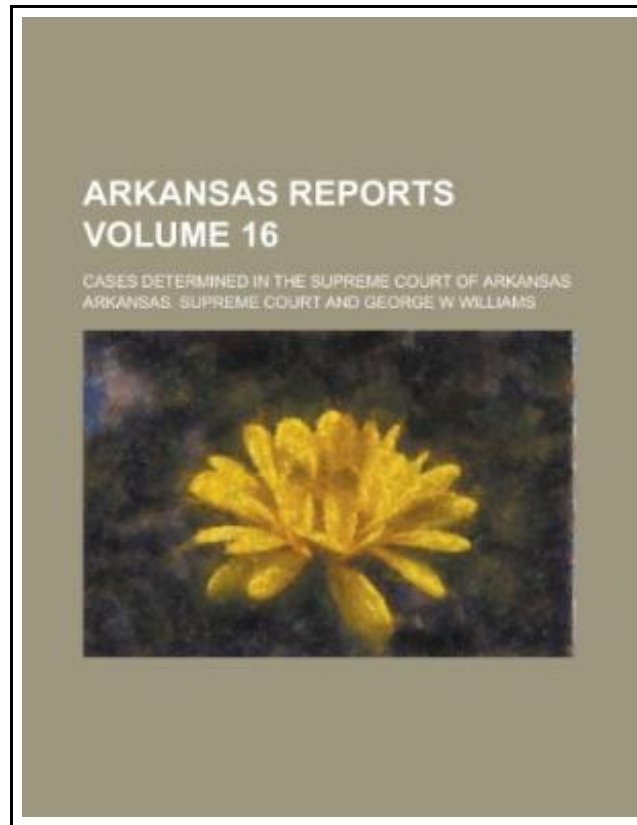

Excerpt: . . . guardians, appointed in any of the States, territories or districts of the United States, whose Wards may have any property within this State, on bringing evidence of his or her appointment, and qualification as such guardian, duly certified and authenticated according to law, to apply to the Probate Court of the county in which such property may be situate, for an order authorizing such guardian to remove said property from this State, to the State, territory, oridistrict, in which such guardian shall have been appointed and qualified as such; and such Probate Court, on being satisfied of the authority of such guardian, shall enter up an order authorizing the removal of such property by such guardian.
